You will gain a wealth of front line experience in developing compliance and ESG systems within a well-established commodity trading firm, and will additionally benefit from exposure to broader legal challenges such as potential work related to personal data protection, sale-purchase contracts, financings etc.

Candidates who prove to be dedicated, dependable, and highly capable through their performance during the internship will be offered a full-time Junior Compliance & Legal Officer position at MRI. # 3. Your Responsibilities

The tasks outlined below are indicative and non-exhaustive. You will be assigned other fixed and ad hoc tasks by the Head of Legal Affairs in response to developing business needs.

#### Administrative:

- Schedule and prepare internal/external meetings, take and circulate notes
- Track and manage the progress of internal/external projects tasks and deadlines
- Liaise with external compliance system/data providers and consultants/counsel on necessary matters

#### Research and Development:

- Assessment and summarization of relevant best-practices, soft and hard laws (across Swiss, EU, English and other legal systems) and/or ISO standards related to compliance and supply chain due diligence topics
- Follow legal press, law firm newsletters, and other media to identify and keep on top of the latest issues and preempt any material developments/changes to laws
- Drafting of relevant policies/procedures
- Categorization of MRI's business flows into internal risk categories, and other preparatory work for Compliance Committee meetings

### **Compliance**

- Carry out KYC assessments of counterparties using Moody's Compliance Catalyst
- Obtaining information to complete MRI's parent company's ESG-related data requests
- Review and escalate counterparty red flags generated by ongoing monitoring
- Draft answers to inward KYC questionnaires
- Conduct outward due diligence of MRI's counterparties for presentation to Compliance Committee
- Assist in facilitating audits and preparing reports to management/external stakeholders

### <u>Other</u>

- Organizing trainings
- Putting together presentations
- Potentially contributing to sale-purchase, project finance, corporate DD legal tasks
- Assisting in the development of broader ESG initiatives (emissions tracking, risk assessments, climate change etc.)
